 Tract or parcel of Land lying in the County of Chatham and State of
 North Carolina containing one hundred Acre more or less butted and
 bounded as followeth to wit Beginning at Post Oak Hommashs cor-
 ner on the County line running with this said line West to a pine
 then North to a Black Oak Corner to his former Entry of Land thence
 East with the said line to a Black Oak on Hommashs line thence
 thence South with the said line to the first Station the same being
 one hundred Acre more or less with all Houses Orchards Garding fences
 Roads & Underwoods Waters and Water Courses thereon standing or grow-
 ing & being with all profits Commodities Advantages & Appertainences

This Indenture made this Twenty second Day of October
 in the year of Our Lord one Thousand seven hundred and Eighty Eight
 Between Hugh Daniell of the County of Chatham and State of North
 Carolina of the one part and Frances Dofset of the S. County and
 State afores. Witnesses that the S. Hugh Daniell for and in
 consideration of the sum of Ten pounds to him in hand paid by the
 above Dofset Frances Dofset and the receipt whereof he the S. Hugh
 Daniell hath Bargained sold and delivered and confirm'd unto the above
 Frances Dofset one certain Tract or parcel of Land containing
 by Estimation Sixty Acre lying and being in the County and State
 afores. and bounded as followeth to wit Beginning in McCarrie line
 at a Post Oak running South to Cages Corner on the S. line thence West
 along the S. Cages line to Dofsets line thence North along Dofsets to
