

This Indenter made this ninth day of September in the year of Our Lord one thousand seven hundred and Ninety one Between William Hardon of the County of Moor and State of North Carolina of the one part and Samuel Stuart of the County of Chatham and State aforesaid of the other part All Witnesseth that the said William Hardon for and in Consideration of the sum of two hundred and thirty pounds in hand paid before the dealing and delivery of these presents, the receipt whereof is hereby acknowledged hath given granted Bargain'd sold Alid and Confirmed & by these presents doth give grant Bargain'd sell Alid and Confirm unto the said Samuel Stuart his heirs and assigns forever all that Tract or parcel of Land laying & being in the County of Chatham and State aforesaid and on the Waters of Little Branch Creek buting & bounding as follows Beginning at a Hickrey on the North Side of S. Hardons Improvement and running along Thompsons line North one hundred and Eighty three pds to a Hickre on Greves line thence down the beam South fifty three pds to a Red Oak at Greves Corner then North along his line across said creek one hundred and Eighty six pds a Pine then South two hundred and Sixty nine pds to a post Oak then North three hundred and nine pds to the first Station containing six hundred and forty acres to have and to hold the said Land and premises, with all and singular the appertinances, thereunto belonging or in anywise appertaining and the Reversion and reversions, remainder and remainders, rents, Issues, and profits thereof and every part and parcel thereof unto the S. Samuel Stuart his heirs, and assigns, to the only proper use and behoof of the S. Samuel Stuart his heirs, and assigns, forever and the S. William Hardon for himself and his heirs, do warrant & defend S. Land forever from any person whosoever living, any such Claim or title In Witness whereof the S.
