#### Page 11 - Statement from Hiram Hardin - Nov 5, 1857

State of Alabama, County of Monroe:

On this fifth day of November AD 1857 personally appeared before me, a Notary Public, within and for the County of Monroe and State aforesaid, Hiram Hardin, aged sixty years, a resident of Monroe County in the State of Alabama, who being duly sworn, according to law, declares that he is the identical Hiram Hardin who was a private in the company commanded by Captain Wolly [Warley] in eighth Regiment of Infantry, commanded by Col. Jack (& Lieut. Col. Manning) in the war with Great Britain declared by the U.S. 18 June 1812; that he enlisted in said war at Pendleton District, S.C. on or about the first day of May A.D. 1813 for and during the war; that he was mustered into the U.S. service soon after at Fort Hawkins, Georgia having enlisted under Lieut Hunter; that he continued in actual service in said war for about two years, & was honorably discharged at Ft. Hawkins, Ga on or about May 1, 1815, as will appear by the muster rolls of said company. He further declares that he has lost his written discharge. He makes this declaration for the purpose of obtaining the bounty land to which he may be entitled under the act passed Sept 28th 1850.

Up to the 20<sup>th</sup> day of March, AD 1882; after which date he had not been employed or paid in the Army, Navy, or Marine service of the United States, except the payment above referred to; that she was married to the said Hiram Hardin on the 1<sup>st</sup> day of February, 1832, at Monroe County, in the State of Alabama; that her name before said marriage was Willday Hicks; that she hereby makes application for the pension which had accrued on aforesaid certificate to the date of death; and that her residence is County of Calcasieu, State of Louisiana, and her Post-office address is Lake Charles, Louisiana.

The old man lives 35 miles from the Court House, and is impossible for him to go there – which accounts for his Declaration being made before a Justice of the Peace.

Some time in the latter part of 1883 I sent to you the application of **Wilda Hardin** widow of Hiram Hardin and therewith sent his discharge as evidence of service, she was

placed upon the rolls and a check sent her for three months pay from the death of her husband, the discharge was not returned of you and it is very important to her in making her second application, service she does not remember toe company or regiment in which her husband belonged, in order to facilitate your reference or search for the discharge which is on file Hiram Hardin was a pensioner from the Knoxville Tennessee district though a resident of this county and state and the check sent **Mrs Wilda Hardin** and paid by the department was 165746. The last one paid ther husband was 56177. If you can possibly find the discharge please return it to her in my care to this office please also forward me blank applications for the widows who have been placed upon the pension rolls. I supposed they had known the old man for many years. But found afterwards that their acquaintance with him did not extend back to the war of the Rebellion. Consequently they an unable to swear that he was loyal – If you will return me the said application. I will file a new one with Witnesses whose acquaintance with him extends more than 2 years. And who can fulfil all the conditions necessary.

I have to say that if necessary I will send a sworn statement of two (2) parties who live in the Parish of DeSoto – near where Mr. Hardin lived. And near the location of the land – who have known him more than 2 years.

I have the honor to suggest that his statements regarding the issue of the Warrant if found comes – can be corroborated in your office, as also those regarding its location – may likewise be found comes by any\_\_ at the General Land Office.

I, HIRAM HARDIN of said state & Parish now applying for a Pension from the United States under No. 30406, Act of Feb. 14<sup>th</sup>, 1871 – HEREBY STATE that I received a Land Warrant from the United States in consideration for my services in the War of 1812. That at the time I received said warrant I was living in Monroe County Alabama. That the said Warrant came to Monroeville Post Office Alabama – Deponent does not remember the name of the lawyer who obtained it for him. That he received it about the year 1851. That the said Warrant for 160 acres was indicated by him in December A.D. 1855 at the Land Office at NATCHITOCHES, LA. On a certain tract of land in DeSoto Parish, La. On a creek called "GRAND CANE" in Sections Four or Five townships, and Range deponent does not recollect. The land lied about five or six miles east from Logansport Post Office. That at the time of locating the said Warrant he had to pay for some seven or eight acres in cash, there being that amount in excess of the 160 acres for which the Warrant called.

HIRAM HARDIN aged eighty one years, a resident of Calcasieu Parish, State of Louisiana, who being duly sworn according to law declares that he is married, that his wife's maiden name was Wilday Hicks, to whom he was married near Clairborne, Monroe County, Alabama in 1831. That he served the full period of sixty days in the military service of the United States in the War of 1812. That he is the identical HIRAM HARDIN who enlisted in Captain Warley's Company (Lieut. Tom Hunter Recruiting Officer) 8th Regiment United States Infantry. (or South Carolina Militia) at Pendleton District South Carolina about the month of December 1812. And was honorably discharged at Fort Hawkins, Ga about the month of March 1815. That he was at Thunderbolt Ga in a fight with the British which lasted two or three hours. Was in a fight with Indians at the Hickory Ground. That his Discharge was stolen out of his pocket book many years ago. That he at no time during the late rebellion against the authority of the United States; adhered to the cause of the enemies of the Government, giving them aid or comfort or exercised the functions of any office whatever under any authority or pretended authority in hostility to the United States. And that he will support the Constitution of the United States. That he is not in receipt of a pension under any previous act; that he makes this declaration for the purpose of being placed on the pension roll of the United States under the provisions of the Act approved February 14th, 1871. That he has only recently become aware (living a a sparsely settled country where few newspapers are taken) that he [begin p. 49] was entitled to a pension. That his post office is at Nibletts Bluff, Calcasieu Parish, State of Louisiana. That his domicile or place of abode is on the public road from Nibletts Bluff to Lake Charles, one and a half miles east from Nibletts Bluff.

That he was always called Hiram Hardin. That if he was borne on the Rolls of Captain Warley's Co. by any other as additional name, he was not aware of it. That he was the only soldier in Captain Warley's Company who bore the name of <u>Hardin</u>. That in

recognition of his services in said company as assigned he RECEIVED A LAND WARRANT for 160 acres of land, which Land Warrant was \_\_\_\_ to him in the name of <u>Hiram Hardin</u>. That said Warrant was located by him on a quarter section of land in DeSoto Parish, La at the Land Office at Na5tchotoches, La. About the month of December AD 1855. That at the time of his enlistment he was about five feet nine inches in height. He had blue eyes and dark hair. That he is now applying to be placed on the Pension roll of the United States under the provisions of the Act of Feb 14<sup>th</sup>, 1871. And that he is honestly entitled to receive a Pension under said Act.
